CHILDREN FROM DISADVANTAGED CIRCUMSTANCES HAVE IMPROVED SCHOOL ATTENDANCE, CLASSROOM BEHAVIOR, CONFIDENCE, AND LEVELS OF ENGAGEMENT WITH THEIR PEERS AND SCHOOL ACTIVITIES WHEN THEY DO NOT WEAR THEIR POVERTY.
